 - Parking All board members and one active parking committee member have ticket books. We do not have scheduled times to actively look for violations, but rely on members to report them.
- Rules and Regs: We've had an increase of residents threatening employees. As a result, we have added a new clause in the rules and regulations which is listed above. Please be aware that breaking any rule reported to the office will result in a warning letter on the first occurrence, a \$25 dollar fine for the second occurrence, a \$50 dollar fine for the third, and a \$100 dollar fine thereafter.
- Parking in Reserved Spots: We ask that everyone concerned be sure the number on your parking spot is visible. If someone still parks in your assigned spot, then please contact the office or maintenance first, and then a board member. To tow, we will need: the make and model of the car, the location of car, and please take a picture proving the car's violation & their license plate number. Even if you are unwilling to see a car towed, a picture of the violation and Village Green sticker will allow us to send a warning letter and fine to repeat offenders. Residents who continually have guests parking in reserved spots will be asked to a mandatory meeting to review the rules.
- **Parking Stickers:** Please be aware that any guest who wishes to park in Village Green more than 7 days is required to get a temporary 30 day parking pass.
- Work Orders Deleted: Please call in all your work orders again, as many were deleted.
